Entry Fee: \$125 per team - Sunday September 5, 2010 (Limit of 100 boats)

Location: Susquehanna River at Harrisburg City Island - Boundaries: South: Above Dock St Dam, North: Below Fiber Dam at Sunbury Blast Off: Safe Light Weigh-In: 2:00 PM Late Return to Weigh-In = Disqualification Blast Off Order will be determined by Application Received Date - Sponsor teams go first. - Registration at Ramp: \$135

RULES

- 2 Person Team per entry
- 5 BASS PER TEAM, MINIMUM, 15" LENGTH
- Smallmouth and Largemouth Bass only.
- Artificial lures only. No live bait. No trolling.
- Only 1 rod may be used per contestant at one time.
- 8 oz. Penalty for dead fish
- Disqualification for all short fish.
- All PA Fish Commission laws apply. You will be disqualified for any infractions.
- PERSONAL FLOTATION DEVICES must be worn while gasoline engine is running.
- Bass must be kept alive in an aerated livewell. A two pump system is required.
- The Tournament Committee has final decision on ALL issues.
- Upon start of tournament, you must stay in your boat except for an emergency. You will be provided with an emergency phone #.
- Legal fish measured from tip of mouth (mouth closed) to tip of longest point on the tail. Fish Commission rules apply.
- Every participant will receive a 2010 Harrisburg Kipona Leukemia/Lymphoma Bass Classic T-shirt
- The tournament will be cancelled if the predicted river stage for the day of the tournament is greater than 10 feet (HBG stage) as reported by the National Weather Service on the day preceding the tournament. The river forecast phone # is (888) 881-7555.
- Boat Owner Must Carry a Minimum Boat Liability Insurance Policy of \$100,000. **Send a copy with your tournament registration.**

PRIZES
