



1st Annual Highspire Boat Association Bass Tournament

Open to the public....Team tournament

Location: Susquehanna River at Highspire Boat Association

Boundaries: York Haven/Red Hill Dams to Interstate 83 bridge just below the Dock St Dam

Entry Fee - \$110 per team Sunday July 18th, 2010

(limit of 49 boats)

Payout will be 75% of entry fee - 15% of field

Blast Off: Safe Light Weigh-In: 3:00 PM Late return to weigh-in = Disqualification

Blast Off Order will be determined by Application Received Date

RULES:

2 Person Team per entry

5 BASS, 15" length limit

Smallmouth and Largemouth Bass only.

Artificial lures only. No live bait. No trolling.

Only 1 rod may be used per contestant at one time.

8 oz. Penalty for dead fish

Disqualification for all short fish.

All PA Fish Commission laws apply. You will be disqualified for any infractions.

PERSONAL FLOTATION DEVICES must be worn while gasoline engine is running.

Bass must be kept alive in an **aerated livewell** . **A two pump system is required.**

The Tournament Committee has final decision on ALL issues.

Upon start of tournament, you must stay in your boat except for an emergency. You will be provided with an emergency phone #.

Legal fish measured from tip of mouth (mouth closed) to tip of longest point on the tail. Fish Commission rules apply.

The tournament will be cancelled if the predicted river stage for the day of the tournament is greater than 10 feet (HBG stage) as reported by the National Weather Service on the day preceding the tournament. The river forecast phone # is (888) 881-7555.

Boat Owner Must Carry a Minimum Boat Liability Insurance Policy of \$100,000. Send a copy with your tournament registration.

PAYOUT

As an example of a 40 boat field: 6 places will be paid totaling \$3,000
1st - \$1,200 2nd - \$600 3rd - \$450 4th - \$300 5th - \$240 6th - \$210

1st Lunker – \$300 2nd Lunker -- \$100
