8OZ PENALTY FOR DEAD FISH

ONE ROD MAY BE USED PER CONTESTANT AT ONE TIME

DISQUALIFICATION FOR SHORT FISH OR CULLING OF DEAD FISH (FISH MUST BE 15 INCHES IN SPRING 12 INCHES IN SUMMER)

ALL PA FISH COMMISSION RULES APPLY, IF YOU GET A TICKET FOR ANY VIOLATION THIS WILL RESULT IN A DISQUALIFICATION FOR THAT TOURNAMENT

THE JRRT BOARD OF DIRECTORS HAS FINAL DECISION ON ALL ISSUES

BOAT OWNER MUST CARRY LIABILITY INSURANCE

WE STRONGLY RECOMMENED LIFEJACKETS ARE WORN DURING TOURNAMENT
